
CERTIFICATE OF AMENDMENT

The provisions hereof constitute the Articles of Amendment of THE LEARNING CENTER, INC. a Georgia nonprofit corporation pursuant to O.C.G.A. § 14-3-1005 of the Georgia Nonprofit Corporation Code.

ARTICLE 1

The name of the corporation is: THE LEARNING CENTER, INC.

ARTICLE 2

The Corporation has no members; therefore, member approval was not required. The amendments were approved by a sufficient vote of the Board of Directors of the Corporation on December 6, 2019.

ARTICLE 3

The Articles of Incorporation of the Corporation are amended by deleting "N/A" under OPTIONAL PROVISIONS found in the original Articles of Incorporation and replaces it as follows:

PURPOSE:

The Learning Center, Inc. is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The purposes for which the corporation is organized are as follows:

- 1. To direct programs for children, youth and adults;
- 2. To offer a stimulating environment for the intellectual, emotional, and social growth of children, youth, and adults in our community;
- 3. To give children and youth positive models, opportunities, experiences and exposure that will provide options in making rational decisions in life;
- 4. To expose children and youth to the world beyond their neighborhoods through activities not only in our area but in other cities and states as well;
- 5. To build character and social skills in children and youth to help ease the sometime turbulent transition from teen-hood into adulthood;

- 6. To foster a sense of self-esteem, self-discipline, responsibility, and respect for others as well as facilitate understanding of their own and other cultures;
- 7. To Improve academic achievement and enthusiasm for academics that is needed for long-term success and self-sufficiency;
- 8. To nurture the desire and enjoyment of learning;
- 9. To support and supplement educational programs in our local schools.

The North American Industry Classification System codes for the corporation are: **624110** – Life skills training, positive social development, drug prevention and **611691** - Tutoring.

The Corporation pledges that all its assets will be used exclusively for its exempt purposes.

NON-PROFIT NATURE:

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The Learning Center, Inc. is not organized and shall not be operated for the private gain of any person. The property of the corporation is irrevocably dedicated to its educational and charitable purposes. No part of the assets, receipts, or net earnings of the corporation shall inure to the benefit of, or be distributed to any individual. The corporation may, however, pay reasonable compensation for services rendered, and make other payments and distributions consistent with these Articles.

DURATION:

The corporation shall have perpetual duration.

GOVERNANCE:

The Learning Center, Inc. shall be governed by its board of directors. The number of directors, and the method of selecting directors, shall be fixed by the bylaws of this corporation.

The management of the affairs of the corporation shall be vested in a board of directors, as defined in the corporation's bylaws.

PERSONAL LIABILITY:

No officer or director of this corporation shall be personally liable for the debts or obligations of The Learning Center of any nature whatsoever, nor shall any of the property or assets of the officers or directors be subject to the payment of the debts or obligations of this corporation.

DISSOLUTION:

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

AMENDMENTS:

The Articles of Incorporation may, from time to time, be amended at a meeting upon the vote of a majority of the Board of Directors of this Corporation in accordance with state and federal rules, codes, statutes, and laws.
